Dear HERA Supervisory Board members,

According to **Rules for recognition of HERA Visitor Centres**, i.e. to item **Decision on the application for certification** within section **4.1. Process of certification**, „At the Board meeting, a final decision on the application will be taken.“

Therefore, please find attached **Application form for recognition of HERA Visitor Centre** and **Evaluation Dossier for HERA Visitor Centre** for the „IAT Teramo Virtual Visitors' Centre“ for the purposes of HERA certification process.

Since HERA Supervisory Board does not yet have its own Rules of Procedure, based on their historical significance for the HERA certification process and their value as a best practice example, **Rules of Procedure for HERA project's Steering Committee shall be used as HERA Supervisory Board's Rules of Procedure.**

Article 5. of these Rules of procedure, adjusted for HERA Supervisory Board, states: „Decisions, which are needed in addition to those made during the meetings of HERA Supervisory Board will be made in written procedure. President of HERA Supervisory Board will deliver the request to all voting members by e-mail, asking for comments or approval. The members can comment on decision drafts within one week of receiving the written materials. If there are no comments provided during this timeframe, the decision will have been adopted as submitted. After the written procedure, President of HERA Supervisory Board informs the members of HERA Supervisory Board of its results.“

If there will be no comments or objections raised **until 09:30 on next Tuesday, the 31st of March, 2020**, Visitor Centre „IAT Teramo Virtual Visitors' Centre“ **will receive HERA certification**. On the other hand, additional procedure shall be in order. In either case, according to the aforementioned article of HERA Supervisory Board's Rules of Procedure, you will be informed of the procedure's results.“
