<p>Evaluation criteria for the comparative procedure</p>	<p>Evaluation criteria of the curriculum and any other documentation:</p> <ul style="list-style-type: none"> - professional experience in ETC projects or programmes, above the minimum requirement; - specific experience in one or more of the themes targeted by the Specific Objectives of Programme¹; - professional experience in maritime Cross Border Cooperation programmes ; - relevant working experience in an international/multicultural environment; - certified knowledge of English language above the minimum requirement; - knowledge of one or both languages of the Programme area. <p>Evaluation criteria in case of interview:</p> <ul style="list-style-type: none"> - good understanding of the EU institutional framework; - sound knowledge of EU regulations and management systems, of ESI funds, with special reference to ETC rules and financial implementation and to Italy - Croatia CBC Programme; - assessment and monitoring procedures in ETC Programmes.
