

## COOPERATION AREA

The **Interreg V A Italy-Croatia Cbc Programme 2014 - 2020** is the financial instrument supporting cross border cooperation among the two EU Member States territories overlooking the Adriatic Sea, aimed to improve the life quality and conditions of more than 12 mln citizens living in the Cooperation Area.

The Italy-Croatia CBC Programme's overall objective is to **increase the prosperity** and the **blue growth potential** of the area by stimulating cross-border partnerships able to achieve tangible changes.

The Programme total budget amount is **236,5 mln €** where around 201 mln € come from the **European Regional Development Fund (ERDF)**. The ERDF co-financing rate is 85% while the 15% is given by the national co-financing.

### MAIN PROGRAMME FACTS & FIGURES



The **cross border approach** will tackle common opportunities and challenges in the Area such as strengthening (blue) innovation, rise of environment quality conditions and climate change adaptation, protection of cultural and natural heritage and sustainable transport development.

Public authorities at national, regional and local level, research centers and higher education institutions, development agencies as well as enterprises, business supporting organizations, NGOs and associations are jointly participating in the development of project ideas and project implementation.
