The processing of your data will be based on principles of correctness, lawfulness and transparency. The data, collected with this form, will be stored safely in a confidential IT personal data archive. According to the Regional Government Resolution n. 596 of 08/05/2018, the Data Controller is Veneto Region Government, with headquarters in Palazzo Balbi - Dorsoduro, 3901, 30123 - Venice; the Data Controller Deputies are: the Director of the Veneto Regional Structure in charge for carrying out the payment of expenses, the data collection and the updating of the IT archive; the Director of the Budget and Accounting Department in charge for the management of the IT Personal Data Archive. Personal data provided may be communicated to other employees of the above mentioned Structures authorized to process personal data. The data will be communicated electronically to the bank that performs the Regional Treasury Service and which is responsible for the payments in accordance with the Articles 46-48 of the Veneto Regional Law n. 39/2001. The Data Protection Officer is based in Palazzo Sceriman, Cannaregio, 168, 30121 - Venezia (dpo@regione.veneto.it). The data will be used with the purpose of paying the due sums, for various reasons, by Veneto Region to the beneficiaries having rights as well as for statistics and archiving purposes. The data will be stored in accordance with the rules in force for the retention and storage of administrative document. The processing of your personal data shall be carried out with computerized methods and manual methods.
