1. Introduction

A Memorandum of Agreement (MOA) highlights the objectives and management arrangements of the AdriaClim Transnational Expert Management Body (TEMB). It also explains general communication, information sharing and consultation processes. This is not a legally binding document, rather it is a channel to improve information and experience sharing among the network members to improve their understanding and knowledge of the Climate change monitoring system.

The AdriaClim Transnational Expert Management Body comprises a complex network of stakeholders that have an interest in the development, management, and adaptation of climate change. Their support, commitment and cooperation in AdriaClim area are essential for the long-term adjustment to climate change.

The purpose of this activity is to establish the AdriaClim Transnational Expert Management Body, to ensure effective consultation (bottom-up/top-down) and consensus during project implementation and beyond. All of the members will be engaged by project partners to form a Transnational Experiment Management Body. Members will sign a Memorandum of Agreement, which will define the network's rules, duties and responsibilities, etc.

Article 1.

The Sides welcomed the cooperation in the framework of the project “ Climate change information, monitoring and management tools for adaptation strategies in Adriatic coastal areas ” (Acronym: AdriaClim) hereinafter referred to as “the project” based on the principles of mutual respect and partnership.

Article 2.

Transnational Expert Management Body aims to ensure effective consultation (bottom-up/top-down) and consensus during project implementation and beyond. As the climate change adaptation, monitoring systems, and management need to be adjusted, and upgraded the benefits for the TEMB members are many. Members will be able to share information, publications and examples of good practices related to climate change; exchange experience on implementing their projects and activities, and continue learning about good practices.

Article 3.

As an informal Body comprised of different organizations across the Italy- Croatia region, the AdriaClim Transnational Experiment Management Body could be potentially involved in the following activities:

fostering collaboration in programme area and beyond;

informally promoting the project scope, outcomes and benefits, which are related to the development of Adaptation plans and monitoring systems to climate change.

members of TEMB will discuss new trends, opportunities, funding calls etc. Communication and information sharing will be informal and will be focused on information sharing and exchange of good practices related to climate change adaptation plans and monitoring systems.

Article 4.

TEMB will work through web meetings (at least in the first year) and will prepare documents and best practices to plan the products definition and uptakes.

Article 5.

All key stakeholders in each region are encouraged to join the TEMB and sign the Memorandum of Agreement, which is an informal, legally non-binding document aimed at promoting cooperation and exchange of experiences in the Italy- Croatia coastal area.

Article 6.




