1. Introduction - Veneto Region

In the context of the work package WP4, an Agreement was formalised between Veneto Region and the Association "Conference of Mayors of Veneto Coast". This Agreement, approved by the Regional Council with Resolution no. 1402 of 16/09/2020, concerns the implementation of the actions of the MARLESS project aimed at involving public authorities, local communities, scientific institutions and the tourism sector in the awareness-raising activities regarding the marine litter issue.

The activities foreseen in the WP4.3 action package are aimed at defining and signing a specific "Coastal Contract", that is a territorial agreement intended as a management tool at local level for the implementation of European, national and regional policies related to environmental protection and adaptation to the effects of climate change.

The scheduled actions aim at strengthening territorial cohesion through the creation of a permanent discussion table, interdisciplinary and cross-sectoral, which allows the planning of a strategy for the integrated management and valorisation of existing territorial resources, starting with water and the problems related to the coastal area.

In this context, the Association identified a list of "stakeholders" to be involved in the participatory process aimed at the drafting and signing of the Coastal Contract.
