At the beginning of the meeting, Olja Ljubišić gave a status update on the TAKE IT SLOW project.

Borislav Puljić and Nikolina Azinović from Arhitecture & Road Design d.o.o. went through the process of preparing the conservation study to which Zehra Laznibat and Eva Žile from the Ministry of Culture, Department for Conservation in Dubrovnik gave their expert inputs.

The discussion between the different stakeholders, led by Franica Miloš, revolved around ensuring the needs of local community are met and that the heritage chosen in interpreted in the most appropriate way.

It was agreed that LP-DNC team will ensure that in the next phase, a team of museologists / heritage interpreters and art post designers (graphics, product, IT and multimedia, lighting and sound) will design all the exhibition elements in the spaces intended for heritage interpretation.

The documentation that will be provided by external experts will cover the main professional trends crucial in the process of developing the new tourist destination of the Rector's Palace in Ston. The main idea of the permanent exhibition is to select key heritage elements (tangible and intangible), explore and design exhibition interpretive messages, themes and narratives, and bring interpretive media that will encourage participation, collaboration and co-creation for the visitors and the community.

In some phases of the preparation of the entire documentation, the premises of the Rector's Palace will be functionally zoned, with a certain thematic-conceptual elaboration and a detailed interpretation plan that will serve as a basis for the preparation of other professional documentation.

At the beginning of the meeting, Franica Miloš and Ana Orlović gave a status update on the TAKE IT SLOW project.

The participants from Ston County and Tourist Office Ston got familiarized with the planned public procurement procedures and gave their feedback, to ensure the delivery will respond to the needs for local community.

The public procurements discussed, with their respective scopes and budgets, included the procurement of the idea design project and main interior design project, procurement of the service for development of the main architecture design project, procurement of the expert for diversification of the tourism offer based on natural and cultural heritage, procurement of service for the implementation of professional and scientific research for the Interpretation centre in Ston, procurement of service of expert for the implementation of the certification procedure for ecolabel / green certification, procurement of the service for creating content for the Interpretation centre (located in Rector's palace in Ston, procurement of service for event organization and public relations, procurement of works for improving accessibility of the Rector's Palace of Ston for establishment of accessible Adriatic heritage interpretation centre, procurement for art installations and the procurement of multimedia and other goods for equipping the Interpretation center.

It was agreed LP/DNC will provide update on the 2022 procurements, namely the procurement of service for the implementation of testing of innovative cross-border tourism products based on natural and cultural heritage and the procurement of event organization services, in the next meeting.

INTRODUCTION

In the opening session Mrs. Valentina Vitković from Ston Municipality greeted everyone and expressed her gratitude for coming in Ston. She did an introduction about Ston Municipality in general, also saying that this project will boost Ston's value of chain and that the Interpretation center will introduce to guests rich natural and cultural heritage and be a dispersive element for further visits to Pelješac, the islands and other parts of the Dubrovnik-Neretva County. Mrs. Vitković also pointed that the Adriatic heritage interpretation center will be managed by the owner – Municipality of Ston.

NOTES

This was the 1st working session of Local Community of Practice of Dubrovnik Neretva County where Regional Agency DUNEA through the activities of 'Technical Support' took the opportunity to present "Smart and Slow Tourism Supporting Adriatic Heritage for Tomorrow", an acronym TAKE IT SLOW. Franica Miloš from Regional Agency DUNEA explained that:

- the core of the project is cross-border partnership of the private, public and scientific sector joint to support the excellence and innovation in the tourism value chain based on smart specialization concept. A strategic Adriatic framework with the policies for destination management will be developed to boost local communities in addressing the tourism industry impacts and at the same time protecting and promoting rich tangible and intangible natural and cultural heritage of the Adriatic coast, its islands, inland and rural areas.
- the new policies will include measures for diversification of tourism products, improvement of the quality of the tourist offer, marketing and promotion actions, certification processes (green / ecolabel, etc.), implementation of local pilot actions with the involvement of individuals and communities, support and optimization of the digital culture, improvement of accessibility and promotion of the heritage sites and training activities and cross-border integration of Adriatic tourist destination management systems.
- ➤ the TAKE IT SLOW project intertwines sustainability, the concept of quality, smart operations, innovation, digitalization and slow tourism which represents a way of giving value to the travel experience, preferring human experiences, relationships with local communities, attention to details, choosing different ways and experiences of visiting, but slowing down the pace through food and wine, cycling, walking, nature and culture of the Adriatic region.



- > The Adriatic Heritage Interpretation Centre will be established in the historical-town of Ston (on the Tentative list of UNESCO World Heritage).
- ➤ The accessibility of the 7 heritage sites in Croatia and Italy will be put in place.
- ➤ 10 cultural and natural heritage sites will be promoted.
- > 10 (agro)tourism entrepreneurs will be guided during the process of obtaining the ecolabels/ green certifications.

Melanija Milić from Regional Agency DUNEA said that the "TAKE IT SLOW" project was prepared by the Regional Agency DUNEA through the activities of 'Technical Support'. "Smart and Slow Tourism Supporting Adriatic Heritage for Tomorrow" is an over 3,7-million-euro worth strategic tourism project co-financed (85%) by the European Regional Development Fund through the Italy - Croatia Cross Border Cooperation Programme. Lead partner is Dubrovnik Neretva Region while project partners are Public Institution for Coordination and Development of Split Dalmatia County RERA, Public institution Development Agency of Šibenik Knin County, University of Zadar, Region of Istria, PROMOTURISMOFVG, Veneto Region, Svim SRL Reggional Development Agency, Molise Region, Apulian Theatre - Regional Consortium for Arts and Culture, Emilia-Romagna Region, Abruzzo Region and Puglia Region. The project is designed to manage and promote the Adriatic Region as a green, smart, sustainable, accessible and slow cross-border tourist destination. She pointed out that the project will enable regional and local stakeholders of DNC to exchange knowledge, and experiences, develop and implement pilot actions, test new policies, product and services with HR and IT partners in order to foster smart, sustainable and inclusive growth in islands, coastal and inland areas of DNC. With its partners and stakeholders, through cross-border cooperation, DNC will address common challenges of great seasonality in tourism, vast gap in development of territory between its overexploited and overpopulated trademark capital Dubrovnik and rural areas as well as overuse of well-known natural and cultural heritage on one hand, and no conservation, valorisation, management and promotion of other joint cross-border heritage such as Adriatic vernacular architecture, gastronomy, lifestyle, etc. Moreover, as a Lead partner, DNC will benefit from exchange of good practices and methodologies in cross border partnership in implementation of strategic framework on regional level. Mrs. Milić confirmed that the AHIC will be later on managed by the owner, Municipality of Ston and that they will do a good job in maintening the idea of a project as well as the Rector's Palace.



Establishing the LCP for the project, Fani Slade from Ston Tourist Board will be the contact person at pilot area. The role and involvement of the LCP, as a group of persons involved in tourism value chain of micro(local) destination is very important through the project. The LCP members will participate at numerous project activities, such as workshops: Smart specialization, study trip to BCC, Smart tourism conference, Assessment of natural & cultural heritage state of art, key stakeholders and target groups on project area where they will develop state of the art of heritage sites, products & services...

After the presentations all participants visited the Rector's Palace in Ston. As part of the implementation of the project "TAKE IT SLOW", the activity of establishing an interpretation center for Mediterranean / Adriatic heritage in the Rector's Palace in Ston is planned. The center is foreseen as a multimedia center of Mediterranean / Adriatic heritage, as a multidisciplinary, multimedia space where, through various arts, design, presentations and different events, typical products, traditional land cultivation and production, customs, way of life and the destination itself will be presented.

Considering that the Rector's Palace building in Ston is protected as part of the Cultural and Historical Entity of Ston (together with the city walls and fortifications), it is necessary to prepare a conservation study in the context of planned works and equipping the Rector's Palace building. The participants at the meeting were also representatives of a firm, *ARHITECTURE & ROAD DESIGN d.o.o*, that will do the conservation study.

At the end of the meeting was short discussion in goal to make clear all LCPs doubts.









1	BILANCIA DI BEPI	In Palazzolo dello Stella, in a naturalistic context of rare beauty, you can see in action today how 40 years ago the "Bilancia di Bepi": a stilt house on the river with a large net (25 mx 25 m) driven by an electric motor. The Bilancia di Bepi is located within the Foci del Stella River Regional Nature Reserve and is the ideal context for enjoying authentic experiences in contact with nature such as kayaking or canoeing tours along the Stella River and in the Marano Lagoon to discover the casoni, or is possible to book a tour by bike or an horse excursion. You can also attend the peculiar fishing experience and taste the specialties directly on site prepared in the food truck located in the park in front of the Bilancia di Bepi. Daniele Ciprian inherited this heritage from his grandfather "Bepi" and his mission today is managing this place preserving the tradition and enhancing the natural heritage.	SLOW TOURISM
2	STAZIONE DI CHIUSAFORTE	Right on the Alpe Adrai Bike Trail that runs along the old railway, the train station building has been transformed into a functional and unique pit stop. The so called "Chiusaforte Station", hosts a bar and small restaurant, a relaxing lounge with a library, a photographic exhibition, free WiFi access and serves as an info point. They can also rent and repair bicycles. In hte bar they use mostly local products from Friuli. The historic building and setting, not far from the town center is surrounded by mountains and woods. 3	FRILAND	Frieland is a new project of sustainable hospitality born in Friuli Venezia Giulia: the first mini-accommodation service on wheels immersed in the nature. A mini house of 12 square metres which contains everything necessary for a holiday. The accommodation is self-sufficient and perfectly integrated with the territory, and is also built with natural materials. When it is moved, it leaves no trace behind it, for an ecological and "green" tourism that more and more people are appreciating. The bathroom has a standard WC (not a chemical one) a washbasin and a nice shower. The kitchen has a large window and is fully equipped, in about one and a half metres there is everything necessary for those who want to cook. The area which stands out the most: the bed next to a huge window. It seems to be sleeping among the trees and the nearby meadows.	SUSTAINABLE TOURISM
4	HOSPITALE DI SAN TOMASO	The small village of San Tommaso di Majano stands on the Via Allemagna, one of the routes that used to lead pilgrims from Northern Europe to the Venetian lagoon before embarking for the Holy Land. At San Tommaso there is the Hospitale di San Giovanni di Gerusalemme. Built and managed by the Knights of the Order of St John around 1199, was intended to provide shelter to travellers and crusaders who needed a safe place in which to sleep and stable their horses. With the end of the crusades and the subsequent decrease of pilgrimages, the hospitale changed its function and was used for agricultural use. Destroyed in the earthquake of 1976, it has recently come back to life again thanks to an association that has taken care of its restoration. The Hospitale now hosts various cultural and artistic activities, and it has resumed its ancient function because of the creation of some rooms dedicated to pilgrims and travellers walking nowdays trought the Via Allemagna. 5	UNA BIBBIA A CILEO APERTO	Cercivento is a typical mountain village in Carnia close to Monte Zoncolan one of the most important skiing resort of the regione FVG. It is surrounded by uncontaminated nature but has also the traces of a rich and important commercial past represented from oldest and architecturally interesting homes. Along the streets and squares of this little village developed the project called "Cercivento: Una Bibbia a cielo aperto" - "An Open Air Bible". It consists of more than thirty artworks (paintings, mosaics, frescoes and photoceramics reproductions) created on the walls of public and private houses. Each artwork is accompanied by related Bible verses in Friulian and Italian language. The project objectives were explained to each participant: the Tourism Department of the Veneto Region is a partner of the strategic project "TAKE IT SLOW, Smart and Slow Tourism Supporting Adriatic Heritage for Tomorrow", under the Interreg Italy - Croatia program, whose partnership is made up of 6 other Italian and 5 Croatian regional bodies. MEETING HIGHLIGHTS AND MAIN CONCLUSIONS

PP8/SVIM organized the 3rd LCP meeting in presence on 9th April 2021 at the Monastery of Fonte Avellana, County of Pesaro-Urbino (Italy).

After the opening session with greetings from Gianluca Carrabs and the Prior Dom Gianni Giacomelli, the first panel was dedicated to present and discuss with the participants the

combined assessment developed by SVIM, based on the results of each questionnaire realized during the 2nd LCP meeting. It was an opportunity to conduct a final evaluation meeting with participants and to raise awareness among LCP members about the opportunities and challenges of safeguarding their intangible cultural heritage and how they could be involved in pilot action.

The second session was dedicated to discuss the work plan, clarifying objectives, outputs and timeline of the pilot action. Gianluca Carrabs and Lucia Catalani explored with the active involvement of all participants some key issues such as: What are our goals? What objectives can be identified to meet those goals? What actions correspond to our objectives? What human and financial resources are available? How long will the pilot action run? What are the expected outputs and results?

Following a detailed assessment, it was decided to set up an information, educational and visitors centre combining content, promotional and cognitive insights concerning the intangible cultural heritage of the Forest Codex of Camaldoli and the attractive resources of the area that can be finally presented and promoted to visitors within a common space.

The main idea is to design and establish an initial point of contact with visitors that can provide anyone interested with some initial information on Codex itself, along with related guidance. The visitors centre will be built around a permanent digital exhibition that explains the Codex and offers an overview of the Monastery and insights into local landscape and natural/cultural attractiveness. It will be equipped with media technology using an attractive mix of different communication methods necessary to rouse visitors' curiosity and keep them as motivated as possible.

The visitor centre will also house an information point of the surrounding area for tourists. A standard set of touristic information should be available at the centre in order to guide visitors through the range of local attractive resources, activities, infrastructures and services and to invite them to experience the different facets of local area.

The next operational meeting is scheduled by the end of April 2021 with the aim to identify logistical arrangements.

After the presentation, she handed the floor to the participants for comments and questions.




The I LCP meeting has been held online the 19th of April.





Meeting of the LCP

Introduction

On the 14th October 2022 at 15.00 the meeting of the Local Community of Practice was held at the Representation Hall of the Municipality of Fasano.

During the meeting, Mr Valerio Palasciano, coordinator of the LCP, shared the "Action Plan" for the conservation, enhancement and management of the natural and cultural heritage of the Terre di Fasano pilot area.

Action Plan

Valerio Palasciano presented the contents of the Action Plan, developed according to the Methodology identified by the University of Zadar, Project Partner, and which will flow into a Join Action Plan Take It Slow.

The Action Plan is the result of a first work carried out with the contribution of the LCP for Evaluation of the state of the art of the natural and cultural heritage of the micro-destination and evaluation of the state of the art of tourism products and services, stakeholders and target groups in the pilot area of the Project.



The Action Plan consists of 20 concrete actions in the short, medium and long term ranging from the implementation of new participatory management tools of the territory, to the infrastructural adaptation with solutions to improve accessibility to places, but which also provides for the proposal of new and diversified experiences dedicated to visitors and the local community for the knowledge of the territory, and teaching aimed at the realities of the territory, as well as strategies for promoting territorial tourism.

During the presentation of the Action Plan, Lino Manosperta, Project Office Manager of PP11, and the Councillor for Tourism of the Municipality of Fasano Pier Francesco Palmariggi intervened to comment on the main points of the Plan.

At the end of the presentation, some members of the LCP spoke. For Play Srl highlighted the importance of an update on the progress of the actions. Masseria Fragnale underlined the importance of enhancing the territory through its witnesses, launching storytelling actions that have citizenship as a target group.

Park Hotel Sant'Elia has declared the importance of creating synergy with high schools in terms of reception, hospitality, narration of the territory. Finally, the LCP confirmed the fundamental role of the Terre di Fasano Business Network, which will have to treasure and promote the results of the project.

The LCP congratulated the work done by the Coordinator Valerio Palsciano, approving the presented Action Plan as definitive.
