Subjects dealing with the management and animation of the heritage are private Owners or Public Bodies managing the sites and PP6/VEN signed with all 11 legal representatives an agreement for 9 years starting from the signature on free loan, then the property will be of the sites. Of course the agreement regulates the loan, duties of both the parts and use of the good. The devices appear in the inventory of the Region (label) and have the TIS logo.

Regarding the CAA Guides (Augmentative and Alternative Communication) PP6/VEN realized n. 10 guides in PDF format and also printed of the heritage. Guides are uploaded in the website of Villas in PDF and were given n. 120 printed copies each for free use. Villas can provide by themselves to print the guide (file for print was provided), or PP6 can provide them a certain number of copies for free (inner copy center).

PP6/VEN is organizing the dissemination of deliverables, such as CAA guides, maps and 3D: we are preparing a mailing list of associations, stakeholders to inform and there will be also communication of improvement of accessibility through the regional tourism website Veneto.eu.

PP6/VEN Tourism Department is also responsible for the three-years Tourism Programme and annual PTA (Piano Turistico Annuale – one-year tourism plan), so in terms of goals and governance the project results in sustainability and slow tourism is already acquired in it, but can be improve thanks to the results of TIS (GP, training, green certifications, dissemination).

- You can take inspiration from the policy tools identified in the project: legislative (regulation, zoning, ...), administrative (collaborative and participatory planning, ...), economic (incentives, revenue management, financing, concessions, ...) and "soft" management (management of flows in some sites, interpretative guides, Eco certifications, ...).

PP6/VEN can act in several frameworks: legislative, administrative, economic, also favoring the moral suasion.

Activities are the participation in other projects in synergy with Take It Slow in order to deal with themes such as sustainability and accessibility, involving LCP in events or in the mailing list for information and dissemination.
