1. Foreword

This document has been produced in the framework of the INTERREG Italy — Croatia Strategic Project CASCADE that develops concerted monitoring, observing, modeling and management approaches to the Adriatic Sea to enhance the knowledge and assess the vulnerability of coastal and marine ecosystems in Italy and Croatia in order to improve the protection of endangered habitats and species.

The CASCADE project will develop a set of concerted and coordinated actions including monitoring (observing and modeling) and management (Maritime Spatial Planning - MSP, Integrated Coastal Zone Management - ICZM, Land-Sea Interaction - LSI) to evaluate the quality and assess the vulnerability of inland, coastal and marine ecosystems in Italy and Croatia with the final objective to restore endangered species and to support integrated management.

The integrated modeling and observing systems will be developed to design and implement Maritime Spatial Planning/Land-Sea Interaction/Integrated Coastal Zone Management, and restoration actions in 11 pilot areas. Pilot actions will assess and protect coastal and marine biodiversity in degraded areas, set up restoration actions, assess the impacts of extreme events on ecosystems and understand how to avoid conflicts and boost synergies in the areas.

The project will consolidate long-lasting research capabilities in the field through a concrete dialogue with stakeholders and the participation of agencies, research centers and universities in order to enhance inland, coastal and marine knowledge. Such shared information and monitoring protocols are essential for supporting concrete actions dealing with environmental vulnerability, fragmentation and safeguarding of ecosystem services at cross-border level. Additional information and updates on CASCADE can be found on the website.

2. Aims and content of the document

Aim of this document is the collection and organization of information on the identified stakeholders and beneficiaries for each Partner/pilot area of the CASCADE project.

The stakeholder identification is an activity functional to the stakeholder analysis and is done by each project partner.

Mapping and analysis of stakeholders are preparatory activities to the definition and design of the Participatory Process and of the strategy for stakeholders' involvement in the preparation of the local



events in which stakeholders will be involved. More than just being able to identify who the stakeholders are in each region for each partner, we have to develop a way to manage them. It's an important task at this point. How do you know who needs what when communicating with them during the project? That will be developed in future steps, and it starts with stakeholder mapping.

This document contains indications and a table collecting and organizing the information on the identified stakeholders by each Partner of CASCADE project. Stakeholders are identified in base of their interest in project cascade outcomes and in base of their influence and prioritization.

All CASCADE partners will actively contribute to communication activities, led by IRB, and will make sure that information about built capacities, results and developed products is effectively disseminated and received by target communities and stakeholders.

3. CASCADE project and the objectives of identification of users/stakeholders

Stakeholder mapping for the Adriatic area has been developed by WP2 leader using inputs from all PPs and an up-to-date contact list will be maintained. Stakeholders have been distinguished into meaningful groups based on their stake, influence, motives and interests. Particularly socio-economic, institutional and academic stakeholders will be distinguished to ease the contact and involvement of the opportune category in the different *CASCADE* activities.

Each PP will actively engage with stakeholders from both public and private sectors, receiving feedbacks through questionnaires, structured interviews and on-stage invitation during public events (Activity 2.4, 5.2, 5.3 and 5.4). Representatives from all CASCADE's target groups, including citizens, marine and coastal professionals and institutions, MPA managers and scientists will also be interviewed and invited to workshops and training events.

Moreover, one of WP5 activities is the preparation of an Ocean literacy toolkit that will be developed to inform and engage stakeholders.

Furthermore, WP5 foresees the organization of dissemination activities, including guided tours and scuba diving for scientific, tourist and recreational purposes; the organization of ocean literacy events (online and in presence events that will provide opportunities to present the essential scientific principles and info, to interact and to dialogue with experts; events are aimed to involve the audience and the stakeholders in active contexts; at least 3 webinars will be organized, experts and renowned speakers will present main topics of the Ocean Literacy challenges, such as threats and opportunities for the conservation of the ecosystems at sea; the participation will be open and public; the video of the webinar will be published on the Ocean Literacy website of the project).

4. Stakeholder mapping

In order to make a policy, a plan, a project successful, it is fundamental first to identify the stakeholders affected/beneficed, and who needs to know what, and when. Before starting, it is important to identify and analyze, and then map, the stakeholders, according to their involvement, emotional and possibly financial investment, and other criteria related to the policy, plan, project, that is going to be designed. Typically, a stakeholder analysis begins with a brainstorming session to whiteboard all the people who may be affected by the project. Once it has been identified the larger pool of stakeholders, it is possible to align them to their level of interest and involvement, possibly on a simple grid chart or in a spreadsheet.

- precondition for any participatory planning process, identification is done "on the desk" by planners but also repeated with representatives of main stakeholders/groups;
- deeper understanding on the issue by the stakeholders and preventing eventual exclusion of relevant stakeholders at an early stage.
- how important it is to involve "that stakeholder"? degree of influence/power to affect outcomes;
- which stakeholders involve in decision-making process? how to communicate, cooperate and associate with them:
- this help later-on in attributing roles/resp., so implementation of actions can be successful while
 possible conflicts between stakeholders should have been already identified /dealt in a early stage.
- assessment of stakeholders interests and the potential impact of these interests on the planned project / Plan / action;
- · stakeholders from different levels will have various motives and expectations to a certain project;
- identifying expectations, benefits from the project, resources to commit, conflicts with the project or with other stakeholders.
- stakeholder involvement strategy: structuring the findings of the preceding steps through the development of a stakeholder participation matrix;
- the matrix will help to know about stakeholders roles & characteristics, how and when to involve them;
- objective of a stakeholder strategy plan is to avoid project failures and to use their capacities to give a contribution as effective as possible.

Stakeholder mapping consists in collecting information on all possible subjects involved (reference people) and classifying them by type (policy/decision maker, technical structure or academic body, beneficiary, citizen, etc.) and relevance in relation to the issues to be tackled. There are certain types of stakeholders who may be involved in any phase, or in a specific phase, and who are identified to perform certain roles, etc.


Stakeholder mapping is the visual representation of a stakeholder analysis, organizing those people according to the key criteria with which you will be managing them during the project. Some of those criteria may include interest, influence, financial stake, emotional stake, etc.

Once the type of stakeholders related to the policy, plan, project, have been identified, their analysis and mapping can be started on the basis of defined criteria for the case. This is where it is important to ask key questions (see the Scheme above) and to be as honest as possible, in assessing stakeholders and their needs.

The following chart represents the useful information to be collected.

Further questions on which to reflect and answer can be the followings:

Who are the stakeholders who have the most influence on your project? From the previous analysis steps (see the Scheme at page 5).

Which stakeholders will be most affected by your project? This can include people from the first group, but may also include outside people directly or indirectly affected by the policy, plan, project, that is going to be designed.

How important people who actually won't be considered stakeholders can be handled? If they are anyway important for the project (power to raise concerns or create a roadblock) keep these people minimally involved since they could have a role they consider adequate or specifically involved by others having power on them.

What are the top motivations and interests of your stakeholders? When deciding the driving force of stakeholders consider: Who has a financial stake/interest, or an emotional interest, What are the top motivations for each stakeholder, Who are the biggest supporters, Who are the biggest "non-supporters".

A further step of stakeholders' analysis, within a proper phase of the Participatory Process design, concerning how and when involve them, how and what to communicate, tools and techniques for involvement, communication and stimulation of participation and contribution, etc., shall be supported and guided by expert facilitators, external or internal to the organization.

The stakeholder analysis consists in the evaluation of the stakeholder role in the Project. They could be strongly interested and directly involved in the Project and/or their professional, research activities and social-economic role could influence the action plan. According to this evaluation it is possible to prioritize stakeholders and insert them in groups with the same Interest/Influence level. Then, every group can be included in communications, consultations and co-design activities.



5. Stakeholder identification and analysis by country

Each Project Partner has provided the list of most important stakeholders in their pilot area. Stakeholders for the CASCADE project have been identified and the contact list of stakeholders has been created.

All the data were gathered together and divided in two tables: one for Italian partners and one for Croatian partners.

Stakeholders have been classified into meaningful groups based on their stake and role. In particular, stakeholders have been divided in three major groups:

- 1. INSTITUTIONAL STAKEHOLDERS (decision/policy makers on EU, national, regional or local level)
- 2. ACADEMIC / SCIENTIFIC/ TECHNICAL STAKEHOLDERS (representatives from Universities, Research Institutes, NGOs, schools)
- 3. SOCIO / ECONOMIC STAKEHOLDERS (Productive organizations (cooperatives, consortium, Aquaculture associations, etc.)

As an outcome of the first round of stakeholder identification, an initial report of stakeholders has been prepared, which identifies relevant stakeholders for the project. 326 stakeholder were identified in total (242 by Italian partners and 79 by Croatian partners).

From 242 identified Italian stakeholders, 105 are academic/scientific/technical (among them several universities, museums, public schools, research groups, NGOs that work on environment, public and private companies that could have interest and impact in environmental changes), 76 institutional (port, regional and city authorities), and 61 socio-economic (different productive organizations, numerous associations, among them several operating in the fisheries and aquaculture sector).

For Croatian stakeholders, 23 are institutional (Zadarska županija, port and city authorities from various parts from Croatia), 30 academic/scientific/technical (among them several universities from Pula, Split Dubrovnik which have teaching program which could benefit from the results of the project), 26 socioeconomic (private hotels, associations and firms which could benefit and be interested to follow project activities).


After the stakeholder identification and classification, we applied a classic tool of stakeholder analysis that allows to analyzing stakeholders by impact and influence based on a four quadrants matrix maps (shown below) that helps to provide insights on the importance and influence of each stakeholder.

Interest indicates the level of engagement of the stakeholder with the goals of the Project and their desire for the project to succeed. Influence indicates their ability to play an active role in its success, such as



committing resources. With this information, it becomes possible to develop a specific approach and strategy for the identified stakeholders and an indication of where to prioritize communication and engagement efforts.

Activity prioritization on the Interest/Influence matrix



The placement of stakeholders across the quadrants also provides an indication of their status to the project. The classic interpretation is:

- High Interest and High Influence = the Primary stakeholders (Group HH);
- High Interest or High Influence = the Secondary stakeholders (Group HL and Group LH);
- Low Interest and Low Influence = the Tertiary stakeholders (Group LL).

Primary stakeholders are essential to the survival and wellbeing of the organization (such as shareholders, employees, customers and those with regulatory authority over the business); secondary stakeholders interact with the project but are not essential to its survival; tertiary stakeholders do not have a relevant



role in the Project because they do not benefit directly from the operations and results of the Project or they do not influence it strongly.
