As part of the Firespill Project with the specific objective of increasing the safety of the programme area from natural and man-made disaster, a high level conference “*Civil protection and crisis management*” was organized by Firespill partner Dubrovnik Neretva County in Dubrovnik on 7th and 8th April.

During the two-day conference, more than hundreds of participants were presented, mainly experts in the field of civil and emergency protection and representatives of regional and local authorities, development agencies, the scientific communities, institutions and rescue services. Disaster and crisis management related to natural hazards like fires, floods and earthquakes were in the special focus of this conference.



On behalf of the Public Institution Rera S.D. for coordination and development of Split-Dalmatia County as the leading partner in the project, Helena Brčić, the FIRESPELL project manager, addressed the media.



"The FIRESPELL project is funded by the Italy-Croatia Interreg Cooperation Programme that is dedicated to supporting the development of science-based regional and local climate change adaptation plans. The European Union focuses on green issues and climate changes, which makes the FIRESPELL project one in a series of projects based on same issues. Crisis and natural disasters are not confined by administrative boundaries, so this cross-border cooperation is important for this reason", said Mrs Brčić.

The conference Civil Protection and Crisis Management brought together more than one hundred participants dealing with urban security and civil protection, and the presented topics related to the reduction of adverse consequences from the risks to which the cross-border area is exposed.

Within the conference, FIRESPELL project partners held Steering Committee and Technical meeting that were also supported online in MS Teams for all partners who were not able to participate in live.


