FIRESPELL Project provides the Emergency Services Regulatory Systems Green Paper to all project partners, in order to favor its disclosure.

Article 1 Definitions

Wherever used in this Agreement, unless the context otherwise requires, the subsequent terms have the following meaning: “**FIRESPELL**” - *Fostering Improved Reaction of crossborder Emergency Services and Prevention Increasing safety Level* is a project that was approved for funding by the European Territorial Cooperation Programme INTERREG V-A Italy-Croatia 2014-2020 and financed by the European Union through the Instrument for ERDF by 85% and the National Co-financing by 15%.

Article 2 Purpose and Scope

The purpose of this Protocol is to establish a collaboration between the Partners and the European Project FIRESPELL for Oil Spills, Earthquakes and Forest Fire Risks Management, in order to prevent and manage the risk of such emergencies in their territories.

This collaboration takes place with the dissemination of the Green Paper produced by the FIRESPELL project to the organizations that are part of the Civil Protection System, in order to encourage and promote the sharing of knowledge, experiences and good practices to improve the risks management.

Article 3 Content of the Memorandum of Understanding

Partners undertakes to accept the Green Paper of the European Project FIRESPELL for the Risk Management of Forest Fires, Earthquakes and Oil Spills and to use it among the references for the definition of strategies and action plans for the prevention and management of the risks. The European Project FIRESPELL is committed to provide the green paper to the Partners, in order to facilitate its dissemination.

Article 4 Institutional framework

After the signature of this Agreement, each Party will appoint a representative who will act as a focal point for the implementation of this Agreement. The focal point will promote the dissemination of the green paper and facilitate exchange of information between the Parties on matters of common interest.

Article 5 Financial aspects

Each Party will bear its own costs incurred in the implementation of this Agreement. This agreement does not represent a commitment of funds on the part of either Party.

Article 6 Duration and Effectiveness

This agreement is effective upon signature of all Parties for a period of 5 (five) years after the Projects completion. It may be renewed and/or amended by mutual written agreement between the Parties.

Article 7 Termination of the Agreement

This agreement may be terminated by either Party by providing 6 (six) months prior written notice to the other Parties.

Article 8 Dispute settlement

All disputes arising from the interpretation and/or implementation of this Agreement shall be settled through diplomatic means.

This Memorandum of Understanding is subject to any approvals and/or ratifications of competence, in order to proceed with the signing and at a later time to provide for the decisions of the individual entities involved.


