## 1. Introduction

The Adriatic Sea houses a large number of diverse and unique marine **ecosystems**. These ecosystems are a key developing factor for **Blue Economy** purposes. Enhancing their attractiveness is compulsory in order to foster **Blue Growth** across the Adriatic Sea. To this aim, ADRIREEF focuses on the development of project outputs able to open concrete opportunities for environment protection and to foster the creation of new economic activities, making the Adriatic area more attractive for SMEs investments and development. Moreover, ADRIREEF is expected to contribute to **knowledge transfer** by drafting relevant documents concerning both decision-makers and blue economy stakeholders.

In order to achieve these goals, a specific activity has been foreseen in the Adrireef Application Form, such as **A.3.5 “Stakeholders’ analysis”**, a systematic way to analyze stakeholders by their power and interest within Adrireef project and generally the Blue Economy sector. This activity is based on a specific strategy – developed by PPs – aimed at profiling and facilitating the involvement of the relevant stakeholders thought 3 main steps: a) Individuation of the list of stakeholders in the Blue economy sectors (e.g. diving, fishing, aquaculture); c) Stakeholder analysis and their potential impact in the exploitation of reefs; c) Reporting of gained results.

This document is the report of the stakeholder analysis and the engagement strategy developed during the first year of the Adrireef project. It sets out the methodology and gives an account of the stakeholder analysis results and established engagement strategies. Also, it sites specific recommendations for further stakeholder engagement on activities concerning the selected case study sites. An effort has been made to summarize the collected information in a comparable format so to provide a comparative overview that can form the basis for further analysis, monitoring and evaluation, and that can feed the process of guidelines development. Hence, this document will provide basis for implementing further project activities, especially A.2.6 “Stakeholders’ survey”.

## 2. Stakeholders' analysis

### 2.1. Activity overview

The stakeholder analysis has been an important issue for both project implementation and dissemination of the results. The mapping was aimed at achieving a double result:

- ⇒ In the implementation phase of the project, it provided an overview of the stakeholders involved in the Blue Economy sector, focused on the countries directly involved in the Adrireef project;
- ⇒ In the communication phase, it allowed the selection and contact of specific actors (public and private) who can play a strategic role both in planning and in informing and awareness-raising activities of other parties involved.

The stakeholder analysis methodology provided partners with a standard strategy, steps and tools to identify, analyse and select stakeholders having the potential to produce a concrete socio-economic impact through the implementation and spreading of the guidelines and code of conduct, which will be part of ADRIEEF's outputs and deliverables.

The methodology approach was focused on the identification of the most relevant bodies – defined as **Key Stakeholders** – starting from those categories of stakeholders considered as strategic for the project purposes (according to the project Application Form) (*Figure n.1*):



*Figure n.1 - Categories of strategical stakeholders*

PPs directly responsible for the research activities were the following:

- Municipality of Ravenna;
- Association for nature, environment and sustainable development SUNCE;
- Public Institution RERA SD for coordination and development of Split-Dalmatia County;
- Zadar County development agency Zadra Nova.

Under the coordination of the responsible PP a specific workplan was developed: as illustrated in the below infographic (*Figure n.2*), to ensure the success of act. 3.5 (and consequently the success of the abovementioned act. 2.6), the mapping is divided in three different and subsequent phases and sub-

phases. All partners were requested to go through the following steps and provide for each step the required output:




Figure n.2 - Workplan

## 2.2. Phase 1: Definition of the methodology

The starting point for carrying out the mapping activity was the development of a matrix aimed at cataloging the stakeholders. This matrix was made of 4 worksheets:

1. Public Authorities (*Figure n.3*)
2. SMEs (*Figure n.4*)
3. Research bodies (*Figure n.5*)
4. General sheet

**N.B Associations and no-profit bodies** in general are compiled in the SMEs category – apart from research bodies

Each worksheet is composed of two main sections:

- Stakeholder details – includes general information, such as company name, a short description of the performed activity, location and stakeholder contacts; each sheet also presents some specific features, that distinguish the target group categories;

- Project impact – includes the classification of the specific elements strictly functional for the project (i.e. influence, contribute and engagement strategy).

The matrix enabled PPs to **classify stakeholders** by:

- category;
- localisation;
- activity;
- possible impact on the project.

For an example of the three specific matrices provided to the PPs, please see the following snapshot):

In reasons of their connection with different areas, each Project Partner was involved in the stakeholders' mapping. A blank matrix was delivered to all PPs for them to complete it with known stakeholders' details. In order to make the scouting simpler, the project foresees the creation of **4 Focal Points** (Figure n.6), managed by the 4 partners engaged in this task:

The Focal Point representatives (*Figure n.7*) are to take care of the following tasks:

- **Send** the matrix to the assigned PPs and guide them in the compilation;
- **Collect and verify** materials before sending them to the LP.



Moreover, in order to gather information on a significant number of relevant stakeholders, each and every PP was required to identify a minimum number of stakeholders. Identified stakeholders' information was to be included in the given matrix. By 24<sup>th</sup> May, each PP of ADRIEEF is to submit to its Focal Point a matrix containing, at least:

- **6** Public Authorities details (3 municipalities or similar and 3 other public authorities);
- **20** SMEs contact details;
- **3** Research bodies.

The mapping activity led to the identification of the following stakeholders (*Figure n. 8*):

Therefore, the first phase of this analysis ended with a **List of stakeholders (Annex n.1 – D3.5.1)** which groups all Italian and Croatian potential actors who could most positively respond to project engagement initiatives. This list would be the working document to carry-out the Stakeholders' analysis and to research their potential impact in the exploitation of reefs, as described in the following phases.

### 2.3. Phase 2: Scoring and identification of key stakeholders

The objective of the second phase is to assess the relative importance of each stakeholder identified in the previous phase in order to establish a weighted hierarchy aimed at identifying Key Stakeholders to involve in the afterwards B2B meeting. In order to achieve this goal, LP carried out an in-depth desk-analysis focused on measuring levels of potential stakeholders' interest and influence over the project: each body is evaluated by a set of standardized enquiries associated to a standardized vote-based evaluation system through a specific methodology based on a quali-quantitative approach.

The desk-analysis of collected matrices is completed by the LP, who applies a set of criteria (**Annex n.2**) as above reported:

⇒ **Qualitative** data (*same for each category*):

- Thematic relevance (score weight 35%): possible impact on the project, as assessed by PPs in the matrix for stakeholders mapping;
- Coherence of stakeholders' mission with the project objective (score weight 35%): desk evaluation of the possible interest in project engagement and dissemination.

⇒ **Quantitative data:**

- Geographic relevance (score weight 10%) (same for each category): it scores the distance from the nearest case study
- Company dimension and possible economic impact (score weight 20%) (only for SMEs): company categorization by dimension (micro / medium / small)
- Impact on local policies (score weight 20%) (only for PAs): the highest score is assigned to local bodies, so to enhance the local impact of ADRIEEF.
- Former experience (score weight 20%) (only for Research): categorization by years of experience.

The quantitative matrices' weighting criteria are same for all stakeholders. Referring to the quantitative data, while 3 out of 4 of the matrices' weighting criteria are same for all stakeholders, there is 1 criterion specifically designed for each and every aforementioned group of stakeholders.

This particular attention in the evaluation system, matched with a score weight system, will return an absolute value for each stakeholder, depending on the sum of the votes of each evaluation criteria. This scoring mechanism guarantees quality and completeness in the evaluation.

The application of the methodology above described allowed the pre-selection of a number of **key stakeholders** for each target group, specifically (*Figure n.9*):

The final stakeholders' matrix (**Annex n.3**) is shared by LP with project PPs and becomes a project management tool which will be updated every 6 months for the entire project duration.

**Key stakeholders' matrix** is highlighted in green (Results column), the other stakeholders are not; criteria shown in the example are not weighted, the overall formula is:

*[Geographic relevance] x [10 %] + [Thematic relevance] x [35 %] + [Coherence of stakeholders' mission project objectives] x [35 %] + [Company dimension or Relevance for local policies or Former experience] x [20%] = RESULT.*

As only one of the last three evaluation criteria has a value different from zero for each category of stakeholder, and as this formula is a sum of weighted criteria, the other two of the tree evaluation criteria are inserted but do not add in the final result. As mentioned before, for each stakeholders' category an ad-hoc evaluation criterion is taken into account, therefore, only one of the last criteria has a value different from zero.

Some specific tables extracted from stakeholders' matrix were realized by LP in order to show and compare results per each category (**Annex n.4**).

## 2.4. Phase 3: B2B Meetings

The first direct involvement of Key stakeholders in the project, was made through the organization of B2B meetings. The direct dialogue with the selected stakeholders was meant to allow to integrate the desk analysis (see par. 2) with the motivational aspects and to collect relevant suggestions on project implementation and further stakeholders' engagement.

B2B meetings are the basis to assess stakeholders' level of participation and information needs, also, they enabled PPs to collect useful elements for the elaboration of stakeholders' surveys (act. 2.6) since, as said, meetings are propaedeutical to act 2.6 (see AF).

The B2B meetings started during the Festivals of Adriatic reefs (act. 2.4) through dedicated training and information sessions. In view of the Festival of Adriatic reefs, and with the aim of collecting a relevant number of B2B minutes, PPs were allowed to schedule meetings well after 30/06/19, providing a natural handover between activities 3.5 and 2.6.


The listed key stakeholders represented a **minimum requirement** in terms of **B2B** – each PP could in fact organize B2B also with additional stakeholders not identified as “key stakeholders” during the mapping. To foster a greater involvement in project activities, PPs were free to contact any stakeholder listed in the scope of this action, to invite them to participate in B2B actions. The choice of engaging non-key stakeholders had to be duly motivated and communicated to the competent Focal Point. The decision may be taken for particular local relevance reasons and/or expected impact on parts of project implementation.

Focal Points, in agreement with all PPs, decided that each Partner would take care of “its own” stakeholders for B2B organizations. The decision was made considering that B2B would be more effective when run by PPs already known by the stakeholders. For this reason, the B2B methodology provided partners with a standard strategy, steps and tools:

- Report: each PP was requested to report on the meetings through a standard form
- Explanatory note: where B2B are not referred to identified “key stakeholders”, PPs were asked to provide an explanatory note justifying their choice.

Overall, the approach should ensure that a **minimum value of stakeholders** is engaged in B2B meetings to explain the scope of ADRIREEF and gather their initial insights in terms of needs, priority areas of cooperation and Blue Economy strategic views.

In the period June – December 2019, PPs organized a total of **114 B2B Meetings** composed of:




Figure n.12 – Key stakeholders achieved on B2B meeting

The collected data show a **wide interest in the project topics from Key Stakeholders'**:




Figure n.13 – Key Stakeholders interesting rate

From the Italian Stakeholders many of the collected suggestions concern the improvement of professional training in the Touristic Field, as strategy that can help the preservation of those many sites in the area to preserve those many sites in the area. Also, the implementation of awareness raising campaigns and the promotion of good behaviours is seen as crucial. The Project is therefore a good opportunity to reach that goal, for the Italian Stakeholder, who also proposed to foster the interaction among several Interreg Project, suggesting the introduction of an annual Festival.

Even according to the Croatian Stakeholders, the focus should be on cliffs preservation and touristic sites conservation, improving the current activities and trying to promote educational programs for children and kids.

### 3. Report of gained results

The stakeholder's analysis aims at evaluating the scope and size of the main Blue Economy Established sectors from Italian and Croatian sides, setting-up a baseline to support stakeholders in the quest for a sustainable development of sea and coastal resources.

In the period June – December 2019 a total of 114 B2B Meeting has been organized by PPs. Three different target groups have been involved in an ad-hoc developed methodology - based on a quality-quantity approach – aimed at investigating the stakeholders' **common feelings, needs** and **proposals** as described below.

In summary, stakeholders identify the Blue Economy as a sustainable way of allowing society to extract value from the seas and coastal regions. Meanwhile, they are aware that this extraction needs to be in balance with the long-term capacity of the oceans to endure such activities through the implementation of sustainable practices. For these reasons, main stakeholders' proposals imply that human activities must be managed in a way that ensures the health of the marine areas and where economic productivity is safeguarded, so that the potential they offer can be realized and sustained over time.

Among issues proposed in the investigation phase, those that found the most interest from the panel of stakeholders were mainly three:



#### **Coastal Tourism**

*Accommodation services and Recreational Activities*



#### **Marine Living Resources**

*Fisheries and aquaculture activities*



#### **Natural Capital defense**

*Sustainable management of maritime areas*



#### **Coastal Tourism**

Coastal Tourism namely covers beach-based tourism and recreational activities and other activities for which the proximity of the sea is an advantage, as well as water-based activities and nautical sports, such as sailing, scuba diving and cruising.

The coastal tourism is the sub-sector which reported the higher responsive rate from potential and key stakeholders. Coastal communities, mainly composed of SMEs, are particularly interested in increasing maritime and coastal tourist flows, still avoiding, or reducing as much as possible, any negative impact on local ecosystems. Therefore, stakeholders' proposals are based on 3 main development drivers:

- ✓ Implement training courses for professionals working in the maritime and coastal tourism sector;
- ✓ Greater protection of natural sites through the application of international best practices aimed at limiting sites wear and damage;
- ✓ Communication campaigns aimed at raising awareness among citizens / potential tourists about the importance and beauty of local natural resources.



### Marine Living Resources

According to the latest reporting documents, EU fisheries and aquaculture production have been stagnant in the last decades. Although in the EU wild-capture fisheries is still the main source of human-food production from the seas, the turnover and economic performance of the EU fisheries and aquaculture sectors have increased over time and they have been identified as sectors with a high potential for sustainable jobs and growth in the Blue Growth Strategy. Therefore, the fisheries and aquaculture communities are mainly composed of SMEs and micro enterprises usually characterized by a low innovation level and particularly vulnerable to economic, financial and political changes.

In the analysed context, there were significant difficulties in involving these categories; moreover, the few fisheries and aquaculture actors involved showed a low collaborative attitude towards project initiatives. This is mainly due to the mistrust of the fishermen in changing or expanding their offers whenever it involves new economic activities and, more generally, to a high level of distrust toward European funds and EU instruments.



### Natural Capital defense

Preserving and increasing the natural capital accumulated in the seas and maritime areas is an important goal for Public Bodies and Research and Educational Center, who highlight the importance of maintaining the maritime areas and seas system in good health in light of the significant economic impact that its degradation could have in the future.

⇒ **Public bodies** - The economic operators working within the involved regions, generally choose a traditional model of economic exploitation of sea and reefs, based on the perception that traditional activities mean fast and safe income, while the transition to sustainable and innovative productive activities would not guarantee it, besides given the period of economic instability people need to be reassured. Therefore, interviewed Public Bodies pointed out the need to augment the information on the profitability of new development models. Guidelines are needed

and they have to be based on clear data and on the evidence that reef exploitation and innovative actions on the reefs are valuable and economically worthwhile. It would be preferable, to propose to SMEs (especially in the fishing sector) a plan to integrate their classical activities with recreational ones and to propose them a model based on the integration of income.

- ⇒ **Research and educational center** –The Blue Economy sector is nowadays an increasingly widespread and studied theme, also thanks to the support of EU funds. The role of the academic world is therefore to converge forces towards a single goal: promoting the contamination and deep interaction between heterogeneous but complementary projects (ie CTE Programs analysing natural ecosystems from different points of view), through the constant sharing of information, skills and tools acquired in the course of projects. To increase this contamination, the main suggestion that comes from interviewed Research and educational centres is to widen the audience of beneficiaries by involving also schools of all types and levels through little projects differentiated by age and course of studies.





## Public authorities




The table shows the sum of the points collected in the 4 relevance cathegories from each Focal Point. Data show a good balance of the four criteria.



## SMEs


