- UNIBO INTERREG Office, Bologna;

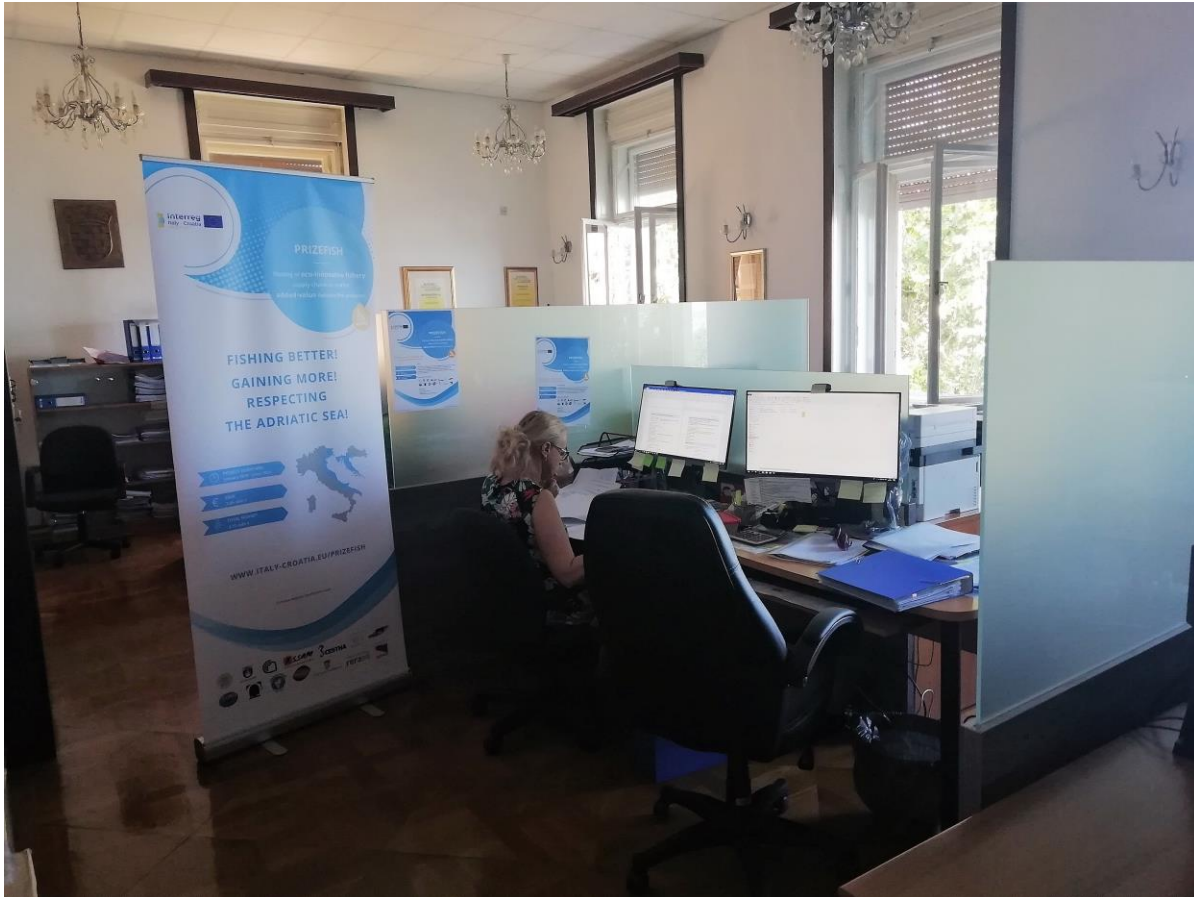
and roll up will be used in all operational activities. The roll up was printed by the printing works F.Ili Cava, located in Castel San Pietro Terme (BO).

PRIZEFISH roll up has been placed in the BIVALVIA institutional premises. The produced roll up will be used in all operational activities and events.



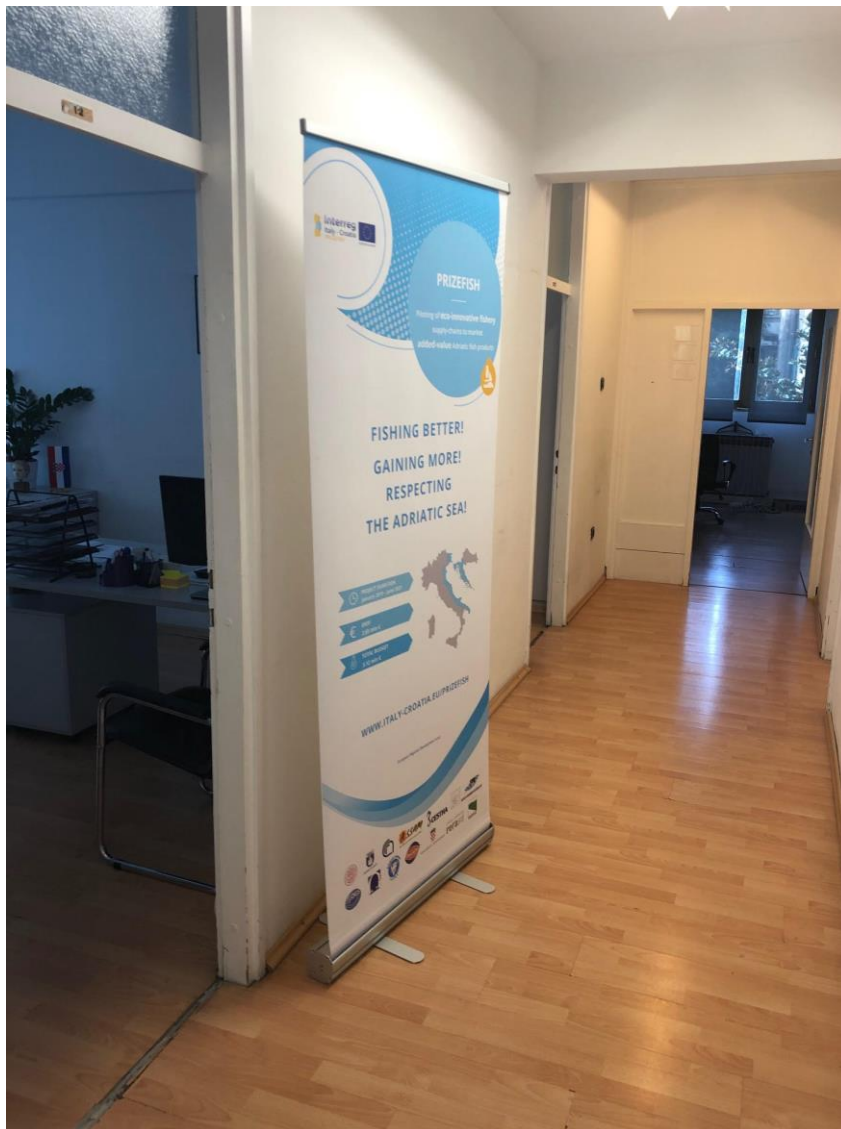
PP11 – MofA
