PERSONAL MEETINGS

The TEMPUS project develops and tests unconventional urban actions to demonstrate how Temporary Use Activities can contribute and to show an active playing role in the urban-heritage-driven regeneration process. To increase comprehension and provide inclusion and integration in existing and well-known practices, an important step is the dissemination of main project results and final conclusions to the creators of the local politics and development strategies.

In the final phase of the project implementation, the project partners in each pilot site held several in-person meetings with representatives of the local or regional authorities to reach out to a policy-making sector to disseminate the TEMPUS main results and conclusions that can contribute and be applied to the urban strategies.
