1. INTRODUCTION

Responsible partner for implementation of WP4 activities is PP4 – PORIN with primary objective to enhance a new economic development based on the valorisation of the hidden tangible and intangible heritage, including the archaeological background and natural contexts of the Adriatic Sea Urban Ports (ASUP), through the start-up of Temporary Uses Actions (TUAs).

The TEMPUS project aims to reach a real change, by leveraging the variegated and peculiar legacy of urban ports, and the untapped potential of local communities through their direct involvement in the definition and launch of urban strategies. To this extent, TEMPUS will implement an integrate set of TUAs, focused on the idea of urban ports as melting pots of traditions, histories, activities, architectures and cultures, which will allow creating new contextual values to be capitalized for triggering wider scale CR Valorization and Regeneration Processes (CRVRP), able to foster wellbeing and the creation of a new sense of living in ASUPs, deeply rooted on their cultural, urban and entrepreneurial dimensions.

Under activities 4.1. titled WP set-up and coordination there are 5 deliverables to be achieved. The first one is D4.1.1. WP4 Working Method. The task is to produce a general working method aimed to provide to the Task Forces (TFs) organization and specific instructions on how to perform WP activities, to outline the risks that could occur during their implementation, and to quide on how to face them.

The overall objective is to coordinate on-fields activities in pilot cities (Rijeka, Split, Ravenna) in order to make them comparable and coherent. The starting working method and instruments, applied and tested during the WP on-field activities, will be developed into the TEMPUS Toolkit to foster the creation of HD entrepreneurial realm in port cities, which is the main WP outputs. Key-elements of the WP implementation will be the engagement of local entrepreneurs for the co-creation of the LES Business Strategies (BSs; A4.3), and for the establishment of the Local Governance Groups (LGGs; A4.4). The CBC collaborative work will be coordinated by the WPL, in close relation with the Partners in charge of the TFsmanagement.

For better coordination of the on-field activities cooperation is needed on territories both at partner level, as well as with citizens, entrepreneurs and innovators.



2. WP4 DESCRIPTION

WP4 is composed of two interdependent paths:

- the first is aimed at valorizing port Cultural Resources (CRs) by developing new Local Entrepreneurial Ecosystems (LES) deeply rooted in local traditions —intended as source of suggestions, ideas, inspirations,
- the second is aimed at creating a port cities' CBC (cross-border cooperation) entrepreneurial realm based on cultural and natural heritage (CNH) protection and promotion.

The goal of the former path is to build a bridge between past (storytelling of port ecosystems evolution in a time span from Roman to modern ages) and present (contemporary interpretation of the past issued by entrepreneurs and innovators); to this extent, two-stage exhibitions (A4.2) will be organized in pilot cities:

- the first stage exhibition will nurture the Open call for Heritage Driven (HD) ideas (A4.3);
- the second one will be fed by the Open call results.

The virtual version of the two-stage exhibitions will be published on the Platform (WP5) to spread the idea of urban ports as melting pots of traditions, histories, activities and cultures.

The purpose of the latter path is to foster the creation of Heritage Driven entrepreneurship in Adriatic port cities, by developing in synergy with the urban strategies co-designed in A3.4 — the Business Strategies of the Local Entrepreneurial Ecosystems (LES; A4.3), and by setting up Local Governance Groups (LGGs; A4.4). LAGs (A3.1) will have the double tasks to co-create Port Cities Urban Strategies (PUCS) (A3.4) and LES BSs, which will lay out the future mid/long-term course for the further development of local entrepreneurial ecosystems. Perspective Forums (PFs) will be organized in order to establish LGGs at the end of the project, with the aim of guaranteeing continuity to the process undertaken; coherently, they will be called to play a double role:

- at local level, they will implement the urban and business strategies, by pursuing a holistic approach;
- at CBC level they will become the operating arms of the Joint Visibility Plan (WP5).



In order to better manage this complex WP, two Task Forces focusing on the two parallel paths will be set-up:

- TF1 "Port cities' history & culture" led by PPMHP, which will manage the implementation of activity 4.2;
- and TF2 "Port cities' entrepreneurial realm" led by CNA RA, which will manage the implementation of activity 4.3.

WP leader will then coordinate the activities carried out in parallel along all the WP activity, and will manage directly the implementation of activity 4.4., in coordination whit the leader of TF1 and TF2.

WP expected outputs are the following:

OP3. TEMPUS Toolkit (TT) to foster the creation of HD entrepreneurial realm in port cities.

TTisaworking documentaimed at spreading a new HD entrepreneurial culture across the Adriatic Sea and beyond; it is based on the following pillars:

- I active engagement of enterprises, for fostering the creation of collaborative environments;
- II awareness rising on the importance of evolving culture through incremental innovation processes, to gain disruptive innovations;
- III creation of closer links between the quadruple-helix actors to facilitate the development of a favorable framework for sharing economy.

TT will sum up the experience gained during the project and will be divided into 4 sections:

- 1 Recommendations to overcome the fear of change, which often creates Catch 22 situations, where owners/entrepreneurs prefer (and pay for) not doing anything rather than experiment new approaches. This section will be mainly fed by the lessons learned accumulated during the implementation of WP4 and in pilots (D3.3.2-5);
- 2 Operating instruments for cultural evolution, which will be derived from the experience gained during the exhibition organization (D4.1.4) and the Call4ideas management (D4.1.3);
- 3 Operating instruments for incremental and disruptive innovation, which will be designed on the basis of:
 - the contents of the CBSs (D4.4.1);
 - the expertise acquired to elaborate ELMs (D4.1.2) and LES BSs (D4.3.4);
 - the knowledge developed to establish LGGs (D4.4.4).
