## 6. Purpose of the event, outputs and main conclusions

The EuroScience Open Forum (ESOF) is a biennial, pan-European, general science conference dedicated to scientific research and innovation. Each conference aims to deliver stimulating content and lively debate around the latest advancements and discoveries in the sciences, humanities, and social sciences.

The Municipality of Monfalcone started to organize the participation in ESOF 2020 in June 2019.

First of all, the theme of the intervention was defined, mainly related to the European project themes managed by the Municipality of Monfalcone, mainly for the SASPAS project of the Italy Croatia programme. Then the abstract of the round table was drafted and 9 speakers were invited. The application and the form, with the information about the topic and the presentation of the speakers, was entered into the platform of the event with the ID Proposal number 1775.

In autumn 2020, the municipality received confirmation of the acceptance of the proposal with a request to reduce the number of speakers from 9 to 5. The new proposal was postponed until December 2019.

Due to the Covid emergency Esوف 2020 was postponed to September 2020.

The format was changed as round tables could be organized remotely or in mixed form (in presence or on site). Due to the health situation, caused by the Covid emergency, two speakers withdrew.

The Municipality of Monfalcone, in collaboration with SELC and the Veneto Region, reshaped the Abstract, including topics from the ECO-SMART project, from the Italy Slovenia programme, and invited two new speakers who were experts in the telematics of the project. The new data have been entered into the platform.

LP and PP1 attended the ESOF2020 event (EuroScience Open Forum) in Trieste (on September 4<sup>th</sup>, 2020) and presented the project during the session “Protection of marine habitats and reduction of CO<sub>2</sub> along coastal areas: scientific and social aspects”. PP1 also moderated the session (A. Rismondo) (link to the session video: <https://www.youtube.com/watch?v=EBxxvfchd94>).



Razgovaralo se o **inovativnoj tehnologiji** koja se koristi za uspješno **obnavljanje degradiranih staništa morske cvjetnice posidonije**, a temelji se na upotrebi **modularnog sidrenog sustava izrađenog od biorazgradivih materijala** kako bi se smanjio negativan utjecaj na morski okoliš. **Presađivanje morskih cvjetnica** jedna je od aktivnosti koju Kornati National Park kao projektni partner provodi u sklopu **Interreg projekta SASPAS** (Safe Anchoring and Seagrass Protection in the Adriatic Sea, Saspas Interreg Italy - Croatia).

Opći cilj projekta je, uz **obavljanja pilot-transplantacija morskih cvjetnica, očuvanje i obnova morskih cvjetnica kroz postavljanje sigurnih sidrišta, obavljanje aktivnosti monitoringa te definiranje integriranog sustava upravljanja za morske cvjetnice u Jadranu**. Očekuje se kako će po završetku projekta biti jasno definirane i predložene mjere prema Europskoj komisiji za povećanje stupnja očuvanosti stanišnih tipova morskih cvjetnica na područjima provedbe Programa.





