## **1. Cross border cooperation network of local authorities and politicians and technicians.**

### **1.1 Background**

During the NETWAP Final Conference, held in Padova (Italy) the 14/12/2021, all project partners shared and signed a Memorandum of Agreement/Understanding. The purpose of this MoU/A is to build a permanent cross border cooperation network at political and technical level, in order to promote and disseminate innovation in waste management methodologies, models and practices, to increase the transnational activity between Italy and Croatia and to support the NETWAP partnership in providing effectiveness and sustainability to its actions.

All partners commit themselves to promote and disseminate in their territories the Memorandum of Agreement/Understanding, in order to make it sign to the largest number of interested public and private institutions, technicians, local and regional authorities, as an effective tool helping the creation of permanent networks.

### **1.2 Cross border cooperation network of local authorities and politicians - Deliverable D**

The purpose of this MoU/A is to build a permanent cross border cooperation network at political and technical level, in order to promote and disseminate innovation in waste management methodologies, models and practices, to increase the transnational activity between Italy and Croatia and to support the NETWAP partnership in providing effectiveness and sustainability to its actions.

In particular, signing the Memorandum, the parties will agree to:

- Share and discuss results and outputs of the pilot actions;
- Disseminate the aims and tools of the innovative waste management methodology and related actions, in view of their possibly adoption in other communities and territories;
- Guarantee the stability of the network through periodic meetings where to share experience and lessons learned;
- Involve local actors committed with the project's development and other stakeholders interested in sharing the project's lessons learned;
- Explore new financing opportunities for the management model reinforcement and replication
- Create new partnerships, synergies and collaborations

## **II. BACKGROUND**

- The NETWAP project has identified waste management as a key environmental challenge in the Italian and Croatian Adriatic region macro region, as it poses considerable risk on the natural and cultural heritage and, consequently, on the touristic and economic development chances of the entire Programme area.
- Both in Italy and Croatia, local governments are constructing new waste management methodology and approaches, as their worries for preserving natural resources is increasing.
- In this context, NETWAP project has tested 2 pilot actions of compost production and plastic collection in Croatia and Italy, and has developed a waste management methodological plan based on the competencies and skills of each partner.
- Creating an Italian–Croatian shared methodology has required an approach that capitalized established methods with best practices of waste management and innovative aspects related to involvement, awareness raising and empowerment of all stakeholders of the project areas.
- Cross border cooperation brought strong benefits to project partners of both sides of the borders. Through this cooperation, it was possible to address the common problem of poor strategies of waste management, with a low level of economic and environmental sustainability, combined with a lack of consistent and comparable data from the areas, that make policy planning and intervention models difficult.
- Cross border cooperation in NETWAP project is pivotal for conceiving relevant strategies, methodologies and action plans and reaching the critical mass in terms of know-how, experience and for exploiting possible economies of scale.
- The definition of cross border innovative tools and methodologies ensure a greatest impact in the target regions and the possibility to leverage public and private funds for future investments.
- Cross border cooperation helps to build a shared and inclusive cross border model strengthening collaborative networks across the regions

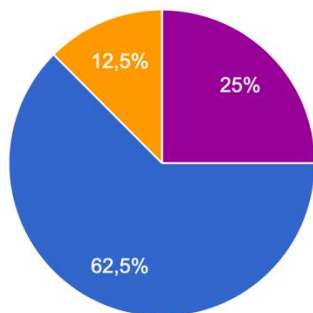

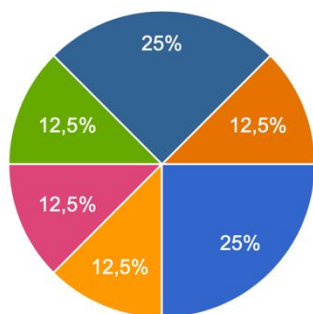

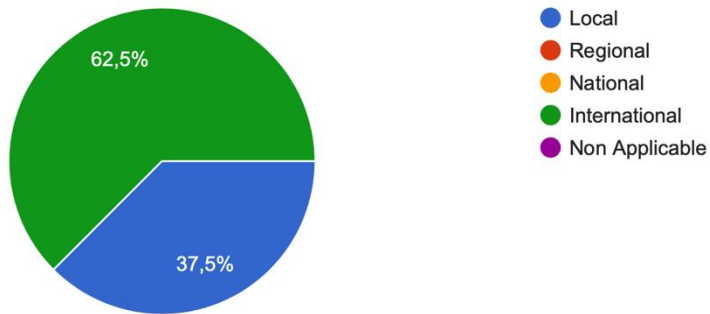
