The DSS and its testing at the Gorizia inland terminal has been carried out on the 25th of November and pilot is in the post implementation follow up.

PP2 presented the project at the final event on the 1st Dec 2021, and performs closing project duties related to inputs for the project transferability and action plans.

One of the main objectives of the DSS is to implement in the future a **Truck Appointment System** (TAS), which will enable a communication exchange between the inland terminal and truck operators, and to support the terminal manager in the optimum scheduling of operations.
