

#### 2.2 Progress status

Port of Šibenik Authority's pilot consists of the implementation of a separated logical module for access control. At the moment, it does not have automated IT solution for this purpose, and especially not for the passenger traffic segment, hence motivation for the proposed content of the pilot project.

Port of Šibenik Authority has since inception of the pilot work plan created technical specification for the activity that was completed in September 2020.

According to the created technical specification, RFQ (request for quotations) was issued as a part of the public procurement process.

A contract has been stipulated with the vendor or integration and development services with company Disk Ltd. from Šibenik, that has commenced with the development activities.

The services vendor is closely cooperating with the Port of Šibenik's DigLogs project manager and PFSO in translating functional specification to deliverables. Since December 2020., a Web server has been set up along with the domain and various functionalities are tested using URL:

Similar activities are ongoing also for the other two applications (mobile application and the police-oriented application).

Envisaged hardware equipment under DigLogs budget has also been procured according to national public procurement rules and installed in identified locations to serve the project purposes.

All activities are ongoing in parallel at the time of creation of this progress report.
