## ETP training summary

Through the Enlarged transfer programme, ICARUS partners wish to share their knowledge with non partner institutions, which aim at achieving similar ICARUS project results. 5 organisations from the programme areas have been selected to attend specific training activities and develop an action plan to improve intermodal passenger solutions in Italy and Croatia.
