- Zadaci Lučke uprave Rijeka u projektu:
- Radni paket 4 (Testiranje poboljšanog prekograničnog pomorskog i multimodalnog prijevoza tereta)
- Nabavljena je suvremena oprema koja se koristi za kontrolu prolaza na sljedećim lokacijama: Ulaz Mlaka, Izlaz Žabica, Brajdica - službeni ulaz, Brajdica - službeni ulaz/izlaz, Lukobran i glavna zgrada Lučke uprave Rijeka
- Oprema uključuje:
 - zamjenu postojećih GRANT kontrolera
 - zamjenu svih oštećenih ili istrošenih elemenata kontrole prolaza
 - ugradnju novih elemenata kontrole prolaza u skladu s trenutnim stanjem i potrebama
 - građevinsko-obrtničke radove za realizaciju pune funkcionalnosti kontrole prolaza na predmetnim lokacijama
